Clinical evaluation of Ayurvedic drug regime after Shodhana in Vicharchika - A case study

ABSTRACT

Now a days we can see a considerable rise in the incidence of skin problems due to various reasons like poor sanitation, unhygienic lifestyle, unhealthy food habits. Due to recurrence and cosmetic disfigurement all skin diseases needs a potent t/t option which will not give symptomatic relief but cure from roots of disease. In the *Ayurveda* text all skin diseases were included under the *Kustharoga*, so included under the *Raktapradoshaja Vikara* and treated as *Kustha*. Selected *Panchakarma* procedures for *Kustha* along with *Shamana Chikitsa* have been proved valuable in these manifestation. Here a case of 32 yrs old female patient presented with symptoms of *Vicharchika*, which was treated with combination of *Panchakarma* procedures and *Shamana Aushadhi*. Patients condition assessed before and after treatment.

INTRODUCTION

Skin disease have a high prevalence through out the world. In developing countries infectious diseases such as tuberculosis, leprosy, whereas in developed countries inflammatory disorders such as Eczema are more common.^[1]

Eczema or dermatitis is a group of inflammatory skin diseases provoked by a wide variety of stimuli i.e. direct injury from toxic chemicals, mechanical trauma and immunological reactions. The term 'Eczema' (Greek for boiling) describes an acutely inflamed weeping skin with vesicals. In the developed world

It is estimated that 10% of people have some form of eczema at any one time and upto 40% of the population will have an episode of Eczema during their lifetime.^[2]

In Ayurveda all types skin diseases have been described under the term *Kustha*. *Vicharchika* is one type of skin disease which can be co-rrelate with Eczema due to similar symptoms. Non contagious soreness of skin along with itching, pain, dryness, scaling is found in *Vicharchika* so we can co-rrelate *Vicharchika* with Eczema.^[3]

Vicharchika is a the type of Kshudra Kustha. [4] All types of Kusthas included under Raktapradoshaj Vikaras. [5] All types of Kusthas are of Tridoshaja origin but according to vitiation of Doshas symptoms occurs. [6] Due to Vata Dosha Rukshata (dryness), Ruja (pain), Krushvaivarnya (Blackish discoloration) occurs, due to Pitta Straava (discharge), Darana (scaling), Kapha is resposnsible for Kandu (itching) found in Kustha so as in Vicharchika. [7] In Ayurvedic classics all principles of management of various skin disease are included under the term Kustha Chikitsa.

Rukshata, Ruja at that lesions from last one and half yrs. Initially she noticed only dryness on foot region and after that there was mild itching from last 6 months there was formation of blackish patches with severe itching, pain, scaling. So she came here for treatment.

RESULTS

The assessment was done with the help of photographs of the lesions and gradation before and after treatment. It was found that *Kandu* was decreased by 3 to 1 after *Virechana*, *Ruja* by 2 to 0, *Rukshata* by 2 to 1, but size of *Mandala* remain as it is. After two settings of *Jalaukavacharana*, *Kandu* was

reduced by 1 to 0, *Rukshata* remain as it is and *Mandala* 3 to 2. After *Shamana Aushadhi Mandala* reduced 2 to 1.

DISCUSSION

The condition was managed with the line of management of *Kustha*. After examining the signs and symptoms, vitiated *Doshas* were *Pitta* and *Kapha*. Here *Rukshana* was given by *Triphala*, *Guduchi*, *Shunthi* and *Musta*. Here decoction was made of all

these Dravyas and was given for Pachana Karma. Among these Triphala having properties of Laghu, Ruksha, Tikshnaguna (hot potency), which alleviates Tridosha and purifies Rakta; it has the property to alleviate skin diseases.[8] Guduchi having properties of Katu Rasa, Madhura Vipaka, Kusthaghni.[9] Musta is also Katurasatmaka, having properties like Deepanaa Pachana.[10] Shunthi is having properties like Katurasa, Laghu Guna and Pachana function.[11] After Pachana, Snehapana with Goghrita was given in increased Matra. After Snehapana, Sarvanga Snehana and Swedana was done for 2 days was done. Then Virechana was given by Tablets Abhayadi Modaka with 30ml Mrudvika Kwatha. Virechana is the Shodhana Karma useful in Raktadusti.[12] After Shodhana therapy, special diet pattern was given as Samsarjana Krama, starting from light diet to normal diet as per *Peyadikarma*. It is for *Agnideepana*.^[13] After that Jalaukavacharan was done in 2 settings after 7 days gap. Jalaukavacharana was done for Sthanika Raktashuddhi.[14] After that Khadira, Darvi and Nimba Kwatha for Sthanika Dhavana was given for Varnaprasadana and Kusthaghna Karya.^[15] Eladi Taila for local application twice a day for Kandughna Karma. After Sarvanga and Sthanika Shuddhi internal medicines were given like Guduchi, Manjistha, Sariva and Vasa Kwatha. Capsule Mahatiktaka Ghrita^[16]1bd and Aragwadhadi Kashayam^[17] for 15 days were given. These all drugs does Raktaprasadana and Kusthaghna Karma.

CONCLUSION

The holistic approach by Ayurvedic Sarvanga Shodhana and Sthanika Shodhana, Sthanika Dhavana and Shamana Chikitsa is helpful in t/t of Vicharchika. As Vicharchika is a type of Kshudra Kustha and Kustha is included under the Raktapradoshaja Vikara, Vicharchika is treated as Raktapradoshaja Vikara, so Virechana was given for Shodhana and Jalaukavacharan for Sthanika Shodhana and Raktaprasadana and Kusthaghna Dravya for Internal Medicines. Combined effect of Nidanaparivarjana, Sarvanga Shodhana, Sthanika Shodhana are helpful for complete relief. These purification measure help to remove the root of the disease and prevention the

disease for its reoccurrence. This case give us an idea for line of t/t in such cases.
